

**CONTRACT FOR ANY TOWN DISTRICT STUDENTS
ELIGIBLE FOR SPECIAL EDUCATION
AND RELATED SERVICES ATTENDING
YOUR TOWN CHARTER SCHOOL**

In accordance with the provisions of ORS 338.165(3), this contract is for charter school students eligible for special education and related services under IDEA between the Any Town School District (ATSD) and Your Town Charter School (YTCS). The parties agree as follows:

1. ATSD is the “resident school district” as defined by ORS 338.165(1) as long as the student’s parent or guardian or person in parental relationship to the student resides in the ATSD and the student is eligible for special education or related services.
2.
 - a. ATSD will be responsible for providing any required special education and related services to the student as required by the student’s individual education plan (IEP), pursuant to ORS 338.165(2)(a).
 - b. ATSD may elect to subcontract these services to City District, YTCS’s sponsoring school district, pursuant to a mutual agreement between Any Town and Your Town. ATSD and YTCS will work together to reach a mutual agreement as to the scheduling of service times and location for services to be provided within YTCS’s facility, in consideration of YTCS’s class schedule, ATSD’s staff scheduling, and the service requirements of the student’s IEP.
3. ORS 338.165 also governs funding related to special education students attending charter schools. The parties understand that each special education student counts as 2.0 ADMw pursuant to 327.013(7)(a)(A). ATSD will distribute to YTCS the following amounts from the State School Fund for those students eligible for special education and related services attending a public charter school pursuant to ORS 338.165(3).
 - a. Forty percent (40%) of TTSD’s Charter School Rate per the most recent State School Fund estimate, which represents the general or standard weight the first basic ADM;
 - b. Forty percent (40%) of the weighted Charter School Rate which includes;
 - c. An additional amount for the annual poverty rate pursuant to ORS 338.157 based on the rate for the charter school’s sponsoring district.
4. ATSD will release payment to YTCS within ten (10) days following receipt of the State School Fund payment to the district [ORS 338.155(8)] and following verification of attendance for an enrolled student who is a ATSD resident and is eligible for special education and related services. YTCS will provide attendance reports to the ATSD’s Director of Finance monthly by the 10th of the following month.

5. ATSD will adjust these rates as updates are made by the Oregon Department of Education during the fiscal year. Payments to YTCS will also be adjusted to reflect changes in ATSD's resident student attendance/enrollment at YTCS or changes in the student's eligibility for special education and related services.
